General

AN Global I.T. S.A.P.I. de C.V. (“**AN Global**” or the “**Company**”), is committed to protecting the privacy of individuals who visit the Company’s website, providing a positive experience on our website and using our products and services.

User Information

Any user information collected by us, such as name, email address, and other contact information, is solely for the use of communication between the user and the company. **AN Global** does not share personal information with third parties.

AN Global gathers information in two ways:

1. Directly (For example, when a form is submitted), and;
2. Indirectly (via website tracking technology and/or cookies.).

AN Global may collect and process the following information:

- Information that is provided by filling in website forms. Whether information is provided is entirely voluntary.
- If we are contacted, we may keep a record of that correspondence.
- Any postings, comments or other content that is uploaded or posted to AN Global’s website.
- AN Global’s website collects information about user computers via cookies.
- Details of visits to our website; the pages viewed and resources accessed or downloaded, including but not limited to, traffic data, location data, weblogs and other communication data.

When this information relates to or identifies a user, we will treat it as “personal data.”

Personal data

AN Global collects personal data of employees, candidates, suppliers, business contacts, and website users. **AN Global** will always attempt to give individuals appropriate notice of what data will be collected and how it will be used. We will only process that data if we consider it fair and lawful to do so. **AN Global** uses personal data for operating our business, delivering, improving and customizing our website and solutions, to send marketing and other communications related to our business, and for other legitimate purposes permitted by applicable law.

Third party

AN Global does not, and will not sell personal data to third parties. However, there may be a time when we need to share or disclose personal data you provide for a specific purpose. For example, AN Global may, at any time, lawfully be required to disclose personal data to third parties in the event that we sell or liquidate any part of the business or assets.

Cookies

Like many websites, **AN Global** uses automatic data collection tools, such as cookies. Cookies are files containing small strings of data which are stored in the user's computer or mobile device when visiting a website. Cookies allow a website to recognize a user's device. **AN Global** may use cookies to collect information as a user navigates the **AN Global** website, such as IP address, location, operating system, browser type, date and time.

When cookies are enabled, they enable a user to navigate between pages efficiently, remember preferences, and generally improve the user experience. They can also help to ensure that the advertisements and other content seen online are more relevant to users and their interests.

By using the **AN Global** website, it is agreed that we can place cookies and other similar technologies on the device used.

Users may disable cookies at any time in the browser preferences tab. If cookies are disabled, please be aware that the performance and the functionality of the AN Global website will be limited.
